- ALL PLANTING SHALL BE IRRIGATED WITH AN AUTOMATIC WATER CONSERVING IRRIGATION SYSTEM IN COMPLIANCE WITH THE COUNTY OF ALAMEDA AND STATE OF CALIFORNIA WATER EFFICIENT LANDSCAPE ORDINANCE.
 - THE IRRIGATION COVERAGE WILL MEET THE WATER REQUIREMENTS FOR THE SELECTED PLANT MATERIAL. PLANTS SHALL BE "HYDROZONED" AND GROUPED BASED UPON SPECIFIC PLANT WATERUSE REQUIREMENTS.
 - THE MATERIALS FOR THE IRRIGATION SYSTEM SHALL BE OF AN EXTREMELY DURABLE NATURE AND SELECTED FOR WEAR RESISTANCE AND LONG LIFE. THE OVERALL SYSTEM SHALL BE DESIGNED FOR EASE OF MAINTENANCE.
 - ALL LANDSCAPE AND IRRIGATION SHALL CONFORM TO THE SPECIAL LANDSCAPE MANAGEMENT NEEDS OF CEMETERIES AS OUTLINED IN SECTIONS 492.4, 492.11, AND 492.12 IN THE CALIFORNIA CODE OF REGULATIONS.
 - ALL PLANTER AREAS TO RECEIVE 3" OF BARK MULCH.
